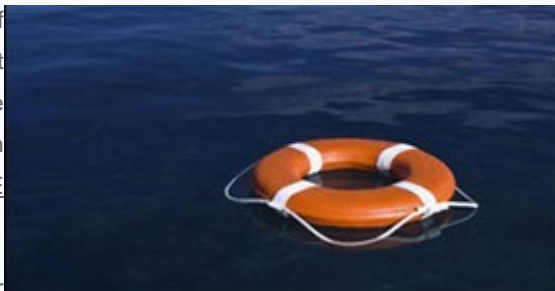




SUMMER IS HERE...Time to Think About Boating Safety

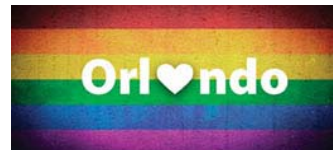
